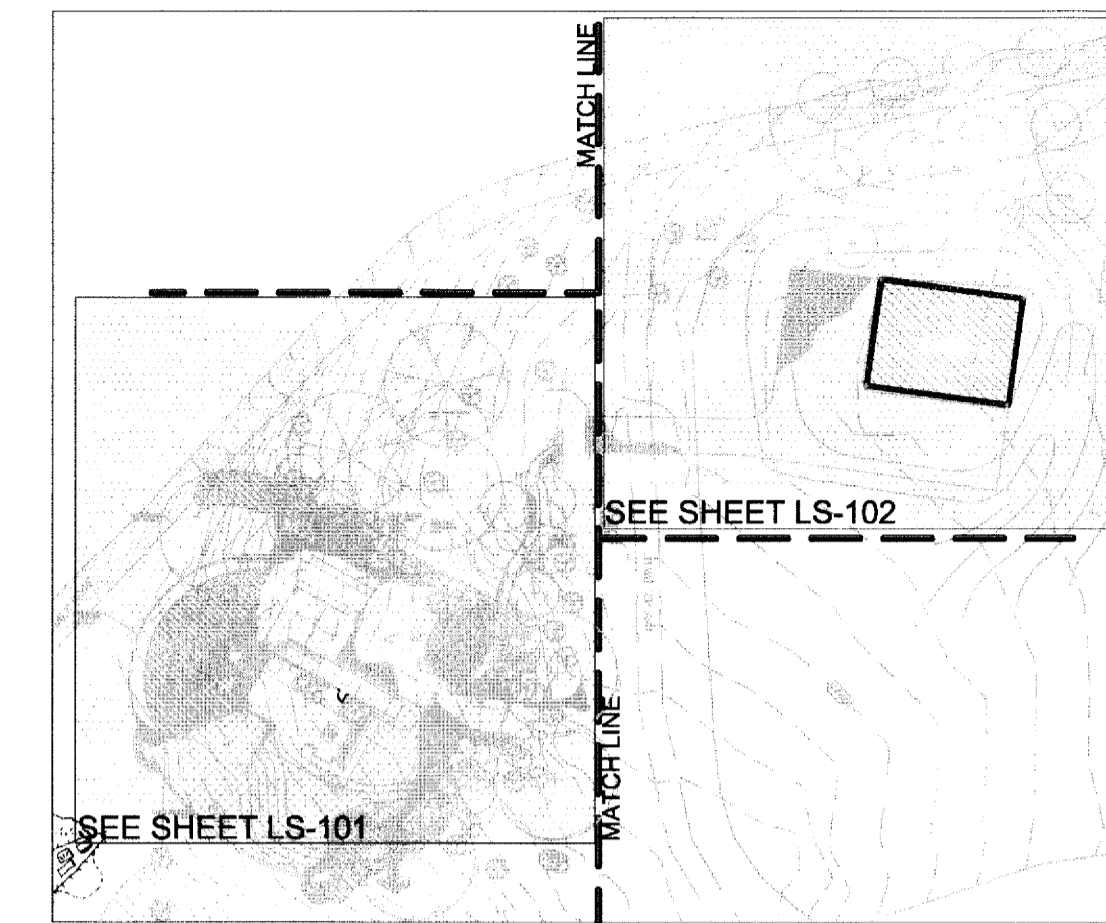


**KEY MAP:**

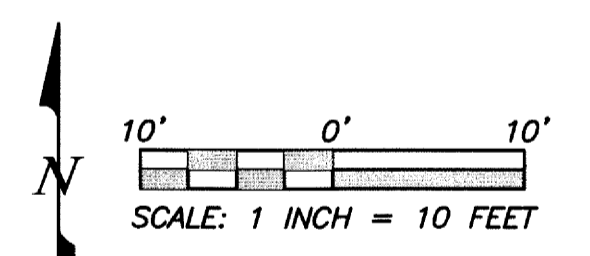

**NOTES:**

1. AREAS TO RECEIVE MULTIPLE SPECIES SHALL BE PLANTED IN RANDOM GROUPS OF FIVE PLANTS OF THE SAME SPECIES.
2. ALL DISTURBED AREAS NOT IDENTIFIED TO RECEIVE PLANTING SHALL BE SEEDED TO BUFFALO GRASS UNLESS OTHERWISE SPECIFIED.
3. INSTALL 1" WIDE STONE EDGING FLUSH WITH FINISHED GRADE.
4. INSTALL ROCK OUTCROPS 50% BURIED INTO GRADE TO CREATE A NATURAL APPEARANCE.
5. INSTALL SMOOTH COBBLES MINIMUM 3" OVER LANDSCAPE FABRIC.
